

United Capital Eurobond Fund | Monthly Fact Sheet

FUND OBJECTIVE

The United Capital Nigerian Eurobond Fund is an open-ended mutual fund that is invested in Dollar denominated Eurobonds, floated by the Federal Government of Nigeria, as well as top-tier corporates. Subscribers can expect to receive competitive short to medium term capital appreciation on their USD holdings invested in the Fund better than they would receive on domiciliary deposits. The minimum investment is \$1,000 and multiples of \$500 thereafter.

MARKET REVIEW, OUTLOOK AND STRATEGY

The Nigerian Eurobond market recorded a broad-based bearish performance in June-2022, following the recent bearish trend in the space in the previous month on the back of the hawkish monetary policy by major central banks globally.

Average yields on FGN Eurobonds inched by 225bps m/m to print at 12.98%. This performance is a consequence of rising interest rates globally and has continued to force Foreign Portfolio Investors into safe haven as they look to reduce their exposure to Sub-Saharan African Eurobonds.

Going forward, the performance of the Eurobond market anchors on the decisions at the next US Fed meeting on the 26th-27th July. The general market consensus is that the US Fed will hike interest rates further, leading to potential sell-offs in sovereign Eurobond instruments. However, we expect yields to be oscillated by increased buy interest from local asset managers seeking improved dollar returns. Also, more robust fundamentals such as rising oil prices and incoming coupon payments should oscillate any sell-offs critical roles in the desired upward trajectory of yields in the Eurobond market

PERFORMANCE REVIEW

In May, the United Capital Nigerian Eurobond Fund returned 0.47% and year-to-date annualized return stood at 5.59%. The Fund's Annualized benchmark return was 7.90% for the same period.

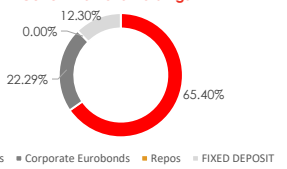
The performance of the Fund during the period was underpinned by mixed sentiments in the emerging market ("EM") sovereign and corporate bonds' space as yields suffered the effect of renewed demand seen on U.S. Treasuries on the back of rising yields. Crude oil, a major source of FX to many some sovereign and corporate issuers maintained its uptrend, with Brent closing the month at \$119/barrel mark.

We will continue to maintain the required allocation ranges in line with the Trust Deed, and tactically pick higher yielding maturities in the sovereign bond space to enhance the performance of the fund.

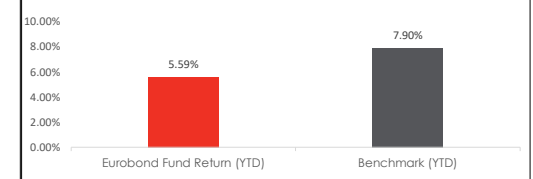

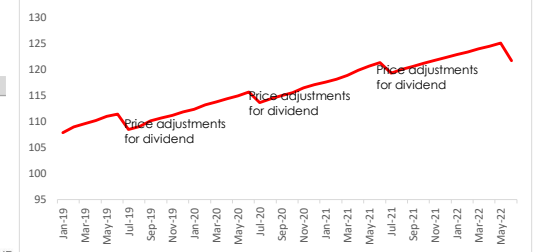
