

Equity Market Summary

Today, the Nigerian Exchange Market closed on a negative note following share price depreciation in ACCESSCORP(-0.71%) and ZENITH(-0.77%). As a result, the benchmark Nigerian Exchange All-Share Index (NGX-ASI) fell by 0.17%, closing at 147,169.88 points. Year to date returns weakened to close at 42.99%, while market capitalisation closed at N93.81tn. Activity level in the market was positive with the total value of stocks traded and total volume of stocks traded rising by 115.11% and 257.22% to close at N29.81bn and 1.97tn units.


