

BRVM Market Summary

On Friday, the BRVM (ICXCOMP) closed on a negative note following share price depreciation in STAC (-7.05%) and UNLC (-6.67%). As a result, the BRVM Composite Index (ICXCOMP) declined by 0.49% to close at 341.95 points. YTD returns settled at -1.10%, while market capitalisation closed at XOF13.18tn. Activity level in the market improved with the total value and volume of stocks traded climbing by 87.53% and 106.02% to settle at XOF1.04bn and 0.39mn units, respectively.
