

## Equity Market Summary

Today, the Nigerian Exchange Market closed on a slightly positive note following share price appreciation in ZENITHBANK (+1.23%) and PZ (+3.77%). As a result, the benchmark Nigerian Exchange All-Share Index (NGX-ASI) rose slightly by 0.04% to settle at 166,129.50 points. Year to date returns settled at 6.76%, while market capitalisation closed at N106.35tn. Activity level in the market declined with the total value and volume of stocks traded falling by 47.08% and 47.82% to settle at N16.72bn and 539.88mn units respectively.

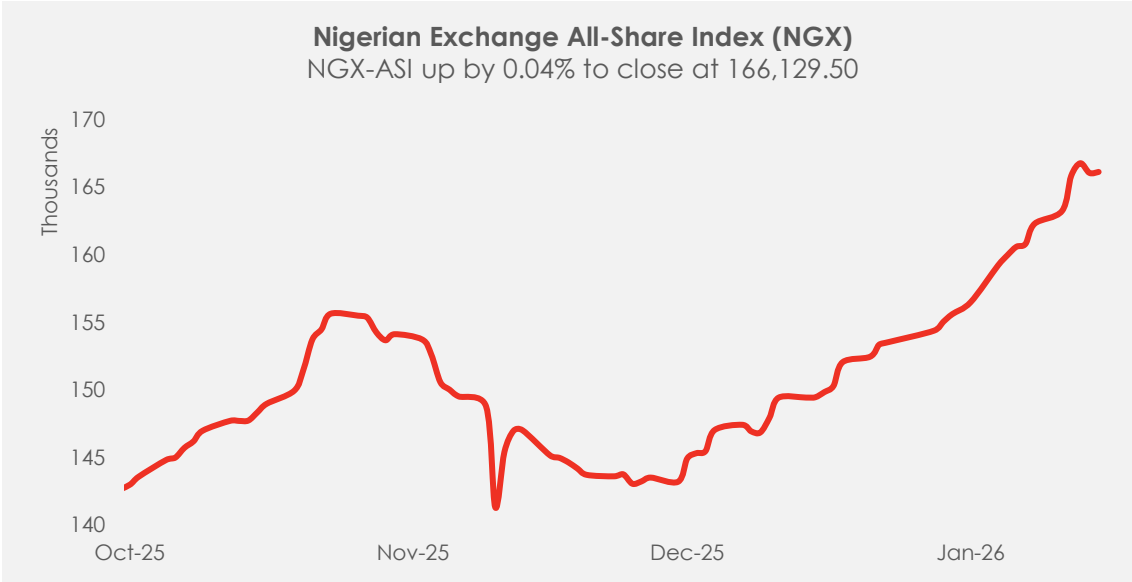

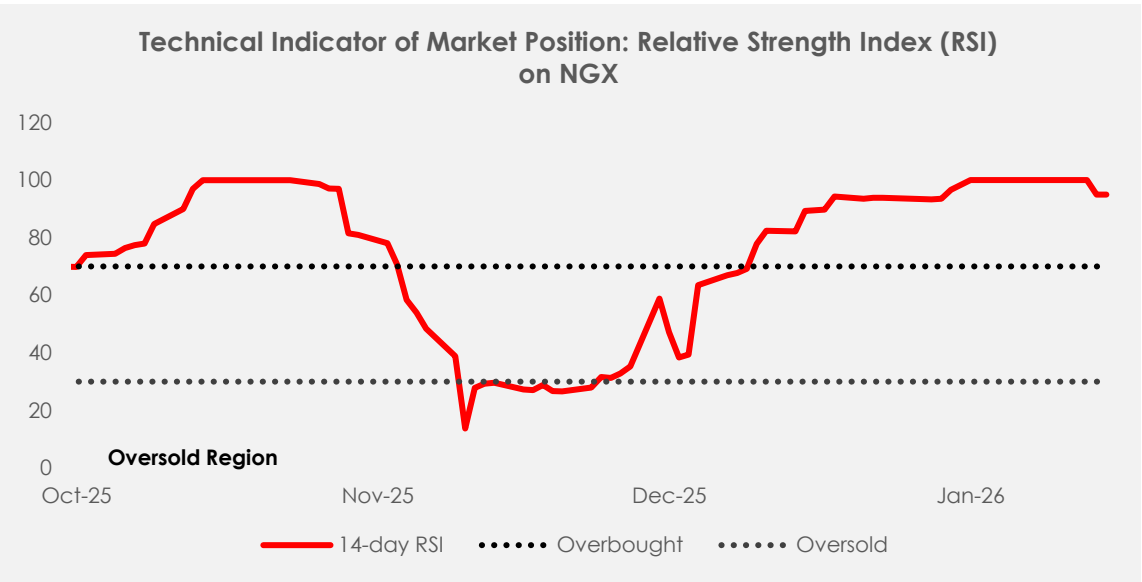
