

Equity Market Summary

Today, the Nigerian Exchange Market was almost flat following share price depreciation in GTCO (-1.57%) and NB (-4.01%). As a result, the benchmark Nigerian Exchange All-Share Index (NGX-ASI) fell marginally by 0.01% to settle at 166,112.50 points. Year to date returns settled at 6.75%, while market capitalisation closed at N106.34tn. Activity level in the market was mixed with the total value of stocks traded falling by 11.74% to settle at N14.75bn. Meanwhile, the volume of stocks traded rose by 16.62% to settle at 629.60mn units.

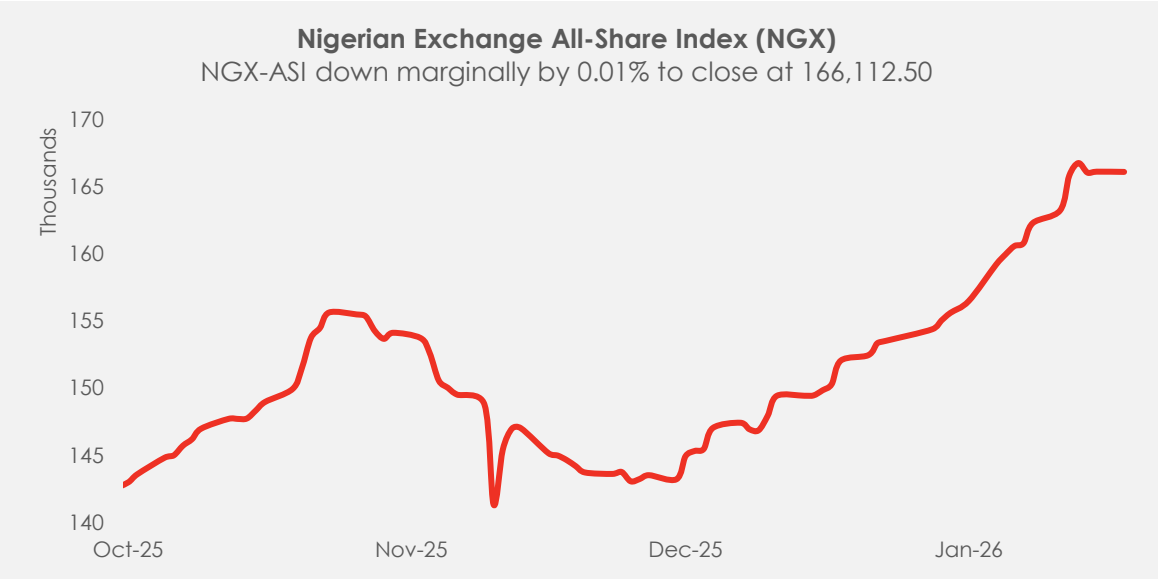

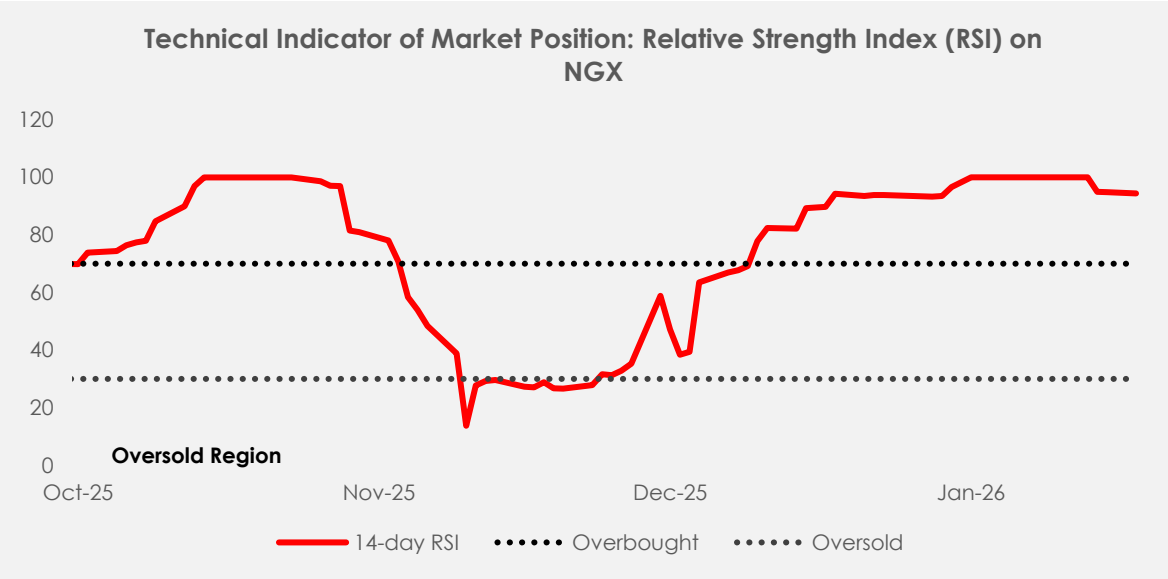
