

### Equity Market Summary

Today, the Nigerian Exchange Market was positive due to share price appreciation in WAPCO (+0.64%) and UBA (+0.79%). As a result, the benchmark Nigerian Exchange All-Share Index (NGX-ASI) settled at 165,713.82 points. Year to date returns settled at 6.49%, while market capitalisation closed at N106.09tn. Activity level in the market was mixed with the total value of stocks traded rising by 0.43% to close at N17.38bn. Meanwhile, the total volume of stocks traded falling by 19.70% to settle at 483.09mn units.



