

**BRVM Market Summary**

On Monday, the BRVM (ICXCOMP) closed on a positive note following share price appreciation in SEMC (+7.23%) and BNBC (+6.79%). As a result, the BRVM Composite Index (ICXCOMP) rose by 0.07% to close at 365.18 points. YTD returns settled at 5.62%, while market capitalisation closed at XOF14.08tn. Activity level in the market was bearish with the total value and volume of stocks traded falling 9.54% and 68.59% to settle at XOF0.94bn and 3.1mn units, respectively.
