

### BRVM Market Summary

On Friday, the BRVM (ICXCOMP) closed on a positive note following share price appreciation in SEMC (+7.43%) and SMBC (+7.41%). As a result, the BRVM Composite Index (ICXCOMP) rose by 0.78% to close at 364.92 points. YTD returns settled at 5.54%, while market capitalisation closed at XOF14.07tn. Activity level in the market was mixed with the total value of stocks traded falling 20.28% while the volume of stocks traded rising by 172.35% to settle at XOF1.04bn and 9.91mn units, respectively.
