

BRVM Market Summary

On Friday, the BRVM (ICXCOMP) closed on a positive note following share price appreciation in STAC (+7.50%) and UNLC(+7.48%). As a result, the BRVM Composite Index (ICXCOMP) rose by 0.82% to close at 409.59 points. YTD returns settled at 18.46%, while market capitalisation closed at XOF15.79tn. Activity level in the market was negative with the total value of stocks traded and total volume of stocks traded falling by 24.51% and 33.92% to settle at XOF 1.38bn and 571.77bn units, respectively.
