

### BRVM Market Summary

On Friday, the BRVM (ICXCOMP) closed on a positive note following share price appreciation in CBIBF (+6.44%) and NSBC(+6.38%). As a result, the BRVM Composite Index (ICXCOMP) rose by 0.74% to close at 412.64 points. YTD returns settled at 19.35%, while market capitalisation closed at XOF15.91tn. Activity level in the market was positive with the total value of stocks traded and total volume of stocks traded rising by 20.82% and 27.52% to settle at XOF 1.66bn and 729.12bn units, respectively.
