

BRVM Market Summary

Yesterday, the BRVM (ICXCOMP) closed on a positive note following share price appreciation in BNBC(+6.02%) and SCRC(+6.00%). As a result, the BRVM Composite Index (ICXCOMP) rose by 0.59% to close at 422.81 points. YTD returns settled at 22.29%, while market capitalisation closed at XOF16.30tn. Activity level in the market was positive with the total value of stocks traded and total volume of stocks traded rising by 100.66% and 88.43% to settle at XOF 1.84bn and 1.06bn units, respectively.
