

### BRVM Market Summary

On Friday, the BRVM (ICXCOMP) closed on a negative note following share price depreciation in ONTBF (-5.37%) and ABJC (-4.92%). As a result, the BRVM Composite Index (ICXCOMP) fell by 0.66% to close at 437.24 points. YTD returns settled at 26.46%, while market capitalisation closed at XOF16.86tn. Activity level in the market was negative with the total value of stocks traded and total volume of stocks traded falling by 14.41% and 3.76% to settle at XOF 1.93bn and 713.63mn units, respectively.
